The following changes, additions, and /or deletions are hereby made a part of the Contract Documents for the JORDAN VALLEY WATER CONSERVANCY DISTRICT LAWN MOWING & EDGING & WEED CONTROL SERVICES, dated February 28, 2019, as fully and completely as if the same were fully set forth herein:

- 1. RECEIPT OF BIDS under NOTICE INVITING BIDS, pg. A-1, shall read: "Sealed Bids will be received at the office of the Jordan Valley Water Conservancy District, located at 8215 South 1300 West, West Jordan, Utah 84088, until 4:00pm on Thursday, March 21, 2019, for the project entitled 'JVWCD Lawn Mowing & Edging & Weed Control Services'. Emailed bids will also be accepted at stevec@jvwcd.org if received by the date and time above. No bids will be accepted after this date and time."
- 2. DISTRICT WEB SITE shall be added to the NOTICE INVITING BIDS, page A-1, under the paragraph RECEIPT OF BIDS, and shall include the following text: Prospective bidders must register at the District's web site (www.jvwcd.org) under "Engineering Projects". Prospective bidders are required to check the District's web site for any addenda prior to submitting a responsive bid. The District's web site will be used to publish updated information related to the project.
- 3. OBTAINING CONTRACT DOCUMENTS under NOTICE INVITING BIDS, pg. A-1, shall read: "The contract documents for the JVWCD Lawn Mowing & Edging & Weed Control Services may be downloaded from the Owner's website www.jvwcd.org beginning March 1, 2019. Service Providers are required to acknowledge receipt of any addenda as part of their bid as provided under the "BID" portion of these documents."
- 4. PRE-BID SITE(S) VISITS under NOTICE INVITING BIDS, pg. A-1, shall read: "A non-mandatory pre-bid meeting and site(s) visits will be held at the Owner's office at 9:30am on Wednesday, March 6, 2019, at which time all

- sites covered under this contract and the work described herein will be discussed. Those wishing to visit all, or part of the sites listed on the BID SCHEDULE will depart from the Owner's office after this meeting".
- 5. Under the "SCOPE OF WORK", pg. C-2, shall be added: Rough field grass areas (that are not turf grass) will be taken care of by District Personnel and will **not** be part of this contract. This pertains to sites #21, #27, #28, & #33.
- 6. Under the "SCOPE OF WORK", pg. C-2, the "Note"s at the bottom of the page shall be changed to: "Note 1" and "Note 2".
- 7. Under the "SCOPE OF WORK", pg. C-2, under the new change "Note 2" shall be added to the existing text: On sites with turf grass inside the fenced areas, the contractor shall maintain the entire site. If no turf grass is located inside the fenced area, the contractor is only responsible for areas outside the fence.
- 8. On the "BID" document, pg. D-1, top paragraph, shall have the word "Fertilizing" removed from the text.
