

NOTICE INVITING BIDS

RECEIPT OF BIDS: Sealed bids will be received at the office of the Jordan Valley Water Conservancy District, Owner of the Work, located at 8215 South 1300 West, West Jordan, Utah 84088, until 2:00 pm on Thursday, September 25, 2014, for construction of the Central Pipeline Project (CPP).

OBTAINING CONTRACT DOCUMENTS: The Contract Documents are titled "Central Pipeline Project." All Contract Documents may be obtained beginning Thursday, September 11, 2014, on the District's website at www.jvwcd.org under the "Engineering Projects" link. Paper documents will only be made available upon request with payment of \$100.00.

DESCRIPTION OF WORK: The Work of this Contract comprises the construction of the Central Pipeline Project and generally includes construction of a 48-inch diameter welded steel pipeline and new Fluoride Facility. The Project has been divided into two (2) separate Bid Schedules. The Owner intends to award a single contract for construction of the Project. Individual schedules will not be awarded separately. The Work generally includes the following:

1. Approximately 31,600 feet of new 48-inch welded steel pipeline and appurtenant structures, including air valve/manway vaults, blow off facilities, a turnout meter vault, cathodic protection facilities, and pipeline connections.
2. A new fluoride injection building located in the Jordan Narrows, with associated civil site improvements.
3. New mainline valve vault located in the Jordan Narrows.
4. New interconnection and flow control vault at the connection with the Jordan Valley Water Conservancy District owned 15000 South Pipeline.
5. Miscellaneous segments of new welded steel pipeline and fittings varying from 14 to 24-inches in diameter.

SITE OF WORK: The Central Pipeline alignment begins at the connection to the existing Central Utah Water Conservancy District owned 48-inch Central Water Project pipeline in Saratoga Springs, Utah, and follows an existing canal, unimproved easements, existing Salt Lake County trails, and public street rights-of-way to a connection point at the Jordan Valley Water Conservancy District owned 48-inch 15000 South Pipeline in Bluffdale, Utah.

PRE-BID CONFERENCE: A pre-bid conference is not required and will be held on an individual basis as requested. Any requests should be submitted to the Engineer. Attendance at a pre-bid conference is not required for a contractor's bid to be considered responsive. No interpretation of the Contract Documents, including any specifications, shall be provided at a pre-bid conference. No information provided at a pre-bid conference, whether oral or written, shall modify or amend the Contract Documents.

CONTRACTOR QUALIFICATIONS: Bidders shall note that this project requires interested contractors to meet certain qualification standards in order for bids to be considered responsive. Bids that do not meet these requirements will not be considered for award. Refer to Instructions to Bidders for further information.

COMPLETION OF WORK: All work shall be Substantially Complete by December 4, 2015.

OPENING OF BIDS: The bids will be publicly opened and read at 2:00 pm, on Thursday, September 25, 2014, at the above-mentioned office of the Owner.

AWARD OF CONTRACT: An Award of Contract, if it were awarded, will be made within 45 calendar days of the opening of bids.

BID SECURITY: Each bid shall be accompanied by a certified or cashier's check, money order or bid bond in the amount of five percent of the total bid price payable to the Jordan Valley Water Conservancy District as a guarantee that the bidder, if its bid is accepted, will promptly execute the contract, provide evidence of worker's compensation insurance, and furnish a satisfactory faithful performance bond in the amount of 100 percent of the total bid price and a payment bond in the amount of 100 percent of the total bid price.

ADDRESS AND MARKING OF BID: The envelope enclosing the bid shall be sealed and addressed to the Jordan Valley Water Conservancy District and delivered or mailed to 8215 South 1300 West, West Jordan, Utah 84088. The envelope shall be plainly marked in the upper left-hand corner with the name and address of the bidder and shall bear the words "Bid for," followed by the title of the Contract Documents for the work and the date and hour of opening of bids. The certified or cashier's check, money order, or bidder's bond shall be enclosed in the same envelope with the bid.

PROJECT ADMINISTRATION: All questions relative to this project prior to the opening of bids shall be directed to the Engineer for the project. It shall be understood, however, that no interpretations of the specifications will be made by telephone, nor will any "or equal" products be considered for approval prior to award of contract.
